

# What Does SEZC mean?

Each company registered in Cayman Enterprise City's special economic zones is required to include this designation, as in for example "ABC Trading SEZC". The letters 'SEZC' in your company's name designate it as a 'Special Economic Zone Company'.

The SEZC designation confirms that your company has met the stringent licensing and due diligence screening requirements of The Special Economic Zones Act, maintains a genuine physical presence in the Cayman Islands within CEC's award winning, globally recognised special economic zone, and is subject to ongoing regulatory oversight by The Cayman Islands' Government's Special Economic Zone Authority (SEZA), which regulates all special economic zones in the Cayman Islands.

All SEZCs have access to the following special concessions:

- No taxation on corporate profits, capital gains, or personal income
- 100% foreign ownership permitted
- 100% exemption from import duties
- A 4-6 week fast-track physical presence set up, inclusive of business license and work visa approvals
- Reduced import duty, business licensing, and work visa fees
- Five year residency granted for employees and their dependents
