


## 8 Questions to Ask Before Establishing your Cayman Islands SEZ Business



There are both public and private schools in Cayman that follow the British or American systems. Grand Cayman has many general practitioners and family medical practices, which are good options in case of a non-acute medical condition requiring treatment and prescribed medication. You can also find private clinics offering specialised services in the areas of cardiology, endocrinology, gastroenterology, neurology, obstetrics and gynaecology, nephrology, paediatrics, pulmonology, and many more.

# 6. What do I need to know about Immigration and Visas?
